#### WHAT IS THE NATIONAL FLOOR SAFETY INSTITUTE (NFSI)?

The National Floor Safety Institute was founded in 1997 as a non-profit 501(c)(3) organization whose mission is to aid in the prevention of slip-and-fall accidents through education, training and research.

#### WHY IS THE NFSI SO IMPORTANT?

Because NFSI is a non-profit organization it has no financial interest in the products tested. This facilitates unbiased testing practices and judgments. When the NFSI logo is placed on a product it is a public declaration that the product has passed comprehensive safety tests.

## WHAT DOES NFSI CERTIFICATION MEAN TO ME?

It's easy to say products provide high-traction support, or reduce the potential for slip-and-fall accidents, but only NFSI certification ensures a product has passed a comprehensive, 2-phase testing process for floor products.

#### WHO IS BEHIND THE NFSI?

The NFSI is led by a fifteen-member Board of Directors comprising of product manufacturers, insurance underwriters, trade associations, and independent consultants.

NFSI is also backed by 19 corporate sponsors ranging from insurance companies to commercial cleaning businesses including State Farm Insurance, Ecolab, Rubbermaid Commercial Products and P&G.
